Cloud Computing

The Internet is everywhere, and so is Cloud Computing. As a result of development in the field of processing, storage technologies, and the internet, IT resources can be accessed from anywhere and have become more powerful and cheaper. Cloud Computing is the latest and most powerful technology that provides different resources—hardware, software, and services to different people according to their requirements and demands. "Cloud Computing is a model for enabling convenient, ondemand network access to a shared pool of configurable computing resources (e.g., networks, server, storage, application, and services) that can be rapidly provisioned and released with minimal management effort or service provider interaction". Cloud Computing is implemented via utility computing, virtualization, service-oriented architecture, and parallel computing. In the Information Technology world, the word "cloud" can be referred to as an amalgamation of networks, hardware, storage, and interfaces to deliver a service.

Nowadays, some IT companies like Google, Yahoo, Amazon, etc. are providing these services to the users, these are called Cloud Service Providers (CSP). There are two more, and the other one is User. The CSP records the profile of each user and DO, and controls all the tasks. The CSP allows DOs to store their data or files on the cloud server, and the users can access these data from the cloud server according to their demand. Cloud Computing delivers applications and IT parties associated with the Cloud Computing, one is Data Owner (DO), and capabilities as a service over the Internet using third-party Resources (CPU, storage, etc.) are delivered as general utilities that are leased and released by the user over the Internet in pay-as-you-go and on-demand basis.

Cloud Computing makes the user tension-free about software, hardware, or any external equipment's availability. Here, users remain unaware of where the data are stored on the cloud servers. Cloud Computing provides an infrastructure for sharing the data, with the user. Nowadays, whatever a person is taking online (retrieving or storing data) by using the internet, everything is on the cloud. In Cloud Computing everything is provided as a

service (Xaas). Services may be in the form of hardware, software, storage, platform, infrastructure database, and many more. NIST presented three major categories of services, known as service models: Software as a service (Saas): Software (application) is delivered over the Internet. Software, which runs on provider cloud infrastructure, is delivered to multiple clients (on demand) through web browsers over the Internet. The consumer does not manage or control the underlying cloud infrastructure including network, servers, operating systems, storage, or even individual application capabilities, with the possible exception of limited user-specific application configuration settings. Examples are Google Docs and Salesforce.com. Platform as a service (Pass): A platform is provided to the client to build (develop, test, and deploy) the applications. The capability provided to the consumer is to deploy onto the cloud infrastructure consumer-created or acquired applications created using programming languages, libraries, services, and tools supported by the provider. The consumer does not manage or control the underlying cloud infrastructure including network, servers, operating systems, or storage, but has control over the deployed applications. Examples are Microsoft Azure and Google App Engine. Infrastructure as a service (IAAS): It offers users elastic on-demand access to resources (server, storage, networking) through service API. The consumer does not manage or control the underlying cloud infrastructure but has control over operating systems, storage, and deployed applications and possibly limited control of select networking components such as host firewalls. Cloud providers typically bill IAAS service on a usage basis, cost reflects the amount of resources allocated and consumed. Amazon EC2 is a good example of IAAS.
